### **Rules and Requirements**

All contestants and judges will report to the Houston ISD Northwest Center located at 6351 Pinemont Drive at **7:30 am, Saturday, April 10<sup>th</sup>, 2010** and register at that time. No contestant will be allowed to participate if not registered by 8:00 am or if all paperwork has not been submitted and approved in accordance with the registration deadline. Judges will meet from 7:30 – 8:00 am.

Buses used for the skills competition will be conventional, 276-inch wheelbase, 71-passenger diesel buses with automatic transmission and power steering or transit-style, 71-passenger diesel buses with automatic transmission and power steering.

The Road-e-o Committee will provide the necessary equipment for the driving skills portion of the contest as well as the written general knowledge exam and pre-trip exam. Each exam will consist of 25 true/false and multiple choice questions. Both exams will be taken at the same time and both must be completed within a single 30-minute time allotment.

Contestants will be given a number by random drawing at the time of registration and will be expected to drive in that order. Contestants must remain in the waiting area until their number is called.

### **NO CELL PHONES WILL BE ALLOWED DURING THE COMPETITION PERIOD!**

Contestants may compete in either the transit or conventional category, but not in both. Contestants winning in either category and proceeding to the State competition must compete at the State level in the SAME category as they did at the Regional level.

Each participant (not alternates) will receive a Certificate of Participation suitable for framing.

### **Trophies will be awarded to winners in the following categories:**

Region IV – Top three winners in Conventional class

Top three winners in Transit class

Region VI – Top three winners in Conventional class

Top three winners in Transit class

Fourth place contestants will receive certificates and will become alternates to compete in the State level competition in the event that one of the top three are unable to compete.

Donuts and coffee will be served at 7:00 am. Lunch will be served for all participating contestants, judges, and volunteers. Observers and family members will be able to purchase a meal ticket the day of the event.
